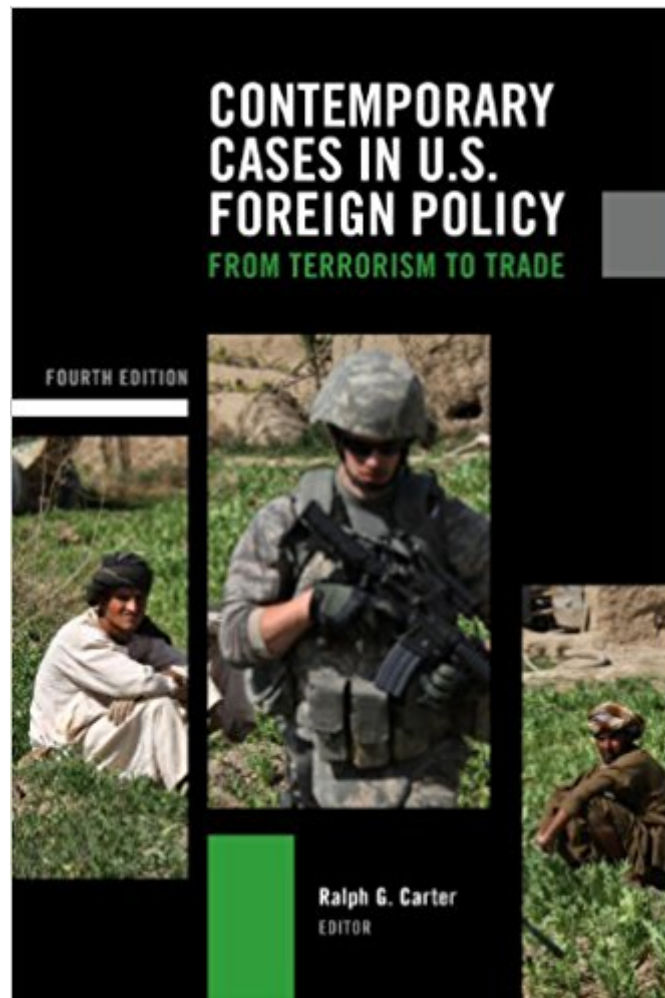

## Synopsis

Crafting foreign policy today is a pluralistic process more actors are involved, partisan loyalties are stronger, and decisions made elsewhere impact the U.S. in significant ways. The president, members of Congress, interest groups, NGOs, the media, and bureaucratic actors all compete to influence the way U.S. foreign policy is shaped and implemented. Editor Ralph Carter captures this interplay with 15 recent real-world cases five brand new to this third edition. Whether grappling with the controversy stemming from immigration reform, dealing with Iran's nuclear weapons program, exploring the impact of the WTO and export tax subsidies, or determining the rights of detainees in the war on terrorism, students are encouraged to question motives, consider alternatives, and analyze outcomes. Each case is consistently structured with a list of before-you-begin questions that frame the issues, introductory and background sections, a timeline of important events, and a descriptive list of key actors.

Ralph G. Carter is professor of political science and former department chair at Texas Christian University. His research interests focus on U.S. foreign, trade, and defense policies and on the domestic sources of such policymaking, with particular attention on the role of Congress. He is the co-author of *Making American Foreign Policy* (1994, 1996). He currently serves as the president-elect of the International Studies Association Midwest Region and previously served as president of the Foreign Policy Analysis Section of the International Studies Association, a member of the International Studies Association's Executive Committee and Governing Council, and as a member of the program committee of the American Political Science Association. His Ph.D. is from The Ohio State University.
